I WAS DISPATCHED TO THE LISTED LOCATION FOR A POSSIBLE ACCIDENT. UPON ARRIVAL I CONTACTED (C) AND (W). (C) STATED HIS VEHICLE HAD BEEN HIT BY (AP)'S VEHICLE IN FRONT OF THE LISTED LOCATION. (W) STATED HE WITNESSED THIS ALONG WITH ANOTHER NEIGHBOR WHOSE NAME WAS NOT ABLE TO BE OBTAINED AT THIS TIME. (W) STATED AFTER SEEING (AP)'S VEHICLE HIT (C)'S VEHICLE HE BEGAN WALKING TOWARDS (AP)'S VEHICLE THINKING (AP) WOULD STAY AT LOCATION. (W) STATED AS HE APPROACHED (AP)'S VEHICLE, (AP) BEGAN DRIVING FORWARD. (W) STATED HE DID NOT HAVE TIME TO GET OUT OF THE WAY AND WOUND UP JUMPING ONTO THE HOOD OF (AP)'S VEHICLE. (W) STATED HE HELD ON UNTIL (AP) FINALLY STOPPED SOME TWO BLOCKS AWAY IN FRONT OF (AP)'S HOME. I FOUND (AP) STILL SITTING IN HIS VEHICLE WHEN I ARRIVED AT HIS HOME. I RETURNED (AP) TO THE SCENE AND HE WAS IDENTIFIED BY (W) AND OTHERS AS THEY ALL LIVE IN THE SAME HOUSING AREA AND ARE ACQUAINTED WITH EACH OTHER. I BOOKED (AP) FOR THE ABOVE LISTED OFFENSE. (REF-90829104-01). (C)'S VEHICLE WAS LEGALLY PARKED IN FRONT OF LISTED LOCATION. IT SHOULD BE NOTED THAT AT FIRST WHILE INVESTIGATING WHAT HAD OCCURRED (AP) DENIED EVER LEAVING HIS HOME. I WAS DISPATCHED TO THE LISTED LOCATION FOR A POSSIBLE ACCIDENT (REF 90829104-01, 02) (C) STATED HE WAS OUTSIDE THE LISTED LOCATION ON THE SIDE WALK AND WITNESSED THE ACCIDENT IN QUESTION. (C) CLAIMED AFTER SEEING (SPV) HIT THE BACK OF A LEGALLY PARKED HE BEGAN TO WALK TOWARDS (SPV). (C) STATED HE FIGURED (SP) WOULD STAY AT LOCATION AND ACKNOWLEDGE WHAT HE HAD DONE. (C) LIVES IN THE NEIGHBOR AS DOES (SP). (C) STATED AS HE APPROACHED THE (SPV) THE (SPV) BEGAN MOVING FORWARD TOWARDS HIM. (C) CLAIMED IT SURPRISED HIM ENOUGH AND HE WAS TOO CLOSE TO THE (SPV) AT THIS POINT TO GET OUT OF THE WAY (C) CLAIMED HE HAD NO CHOICE BUT TO JUMP ONTO THE (SPV) HOOD TO AVOID BEING RUN OVER. (C) CLAIMED THAT HE REPEATEDLY SCREAMED FOR (SP) TO STOP THE (SPV) BUT (SP) DID NOT AND IT APPEARED TO (C) AS (SP) WAS TRYING TO GET (C) TO FALL OFF WHILE HE WAS DRIVING. I WAS NOT ABLE TO LOCATE ANYONE WHO WITNESSED THIS INCIDENT NOR DID I SEE ANY INJURIES ON (C). (C) DID CLAIM THAT HIS FRONT THIGH AREAS WERE SORE BUT REFUSED EMS ON SCENE.
